#### 3. Invocation.

#### 5. Opening Remarks

The Mayor stated that the projected date to reopen the city hall is July 01, 2020, but there is a possibility that there will still be restrictions. ## 10. Open Forum:

No one signed up to speak.

## 11. Mayor's Report

- The Mayor updated the council on COVID-19. She stated that Henderson County had not publicized any increases in COVID-19 for the past couple of weeks, and did not renew their disaster proclamation. She stated that later in the council meeting, the council will have an opportunity to extend the Coffee City disaster proclamation if warranted.
- She stated that there are a few other corrections that need to be made on the FY 2020 Q3 budget review.
- She stated that the city had met with and secured a new auditor for the city. She went on to say that there had been changes in the way city audits were conducted, and the auditor will be working with us in the future, to get our books in-line with these changes. She went on to say that his pricing was a little more than projected, but that the CPA does provide ongoing support throughout the year. The auditor will start in July and should have the audit completed within 90 days. The Mayor said that she had spoken to the EDC board regarding their portion of the audit requirement.

## 12. City Secretary's Report

- Runoff election for Henderson County will be on July 14th 2020.
- Within the next few weeks, we will be preparing for the November 3<sup>rd</sup> elections. Coffee City has three council places open, and a mayor's position that will be on the ballot.
- The City Secretary said that after meeting the new auditor, he came away with a good feeling about the auditor's expertise.

#### 13. EDC Report

EDC President Jim Beggerly spoke. He apologized for the confusion about the prior EDC meeting, and said that he had been corrected in the fact that the meeting must have a physical location. He stated that there had not been any changes in the potential sale of the Lake Palestine Business Center. Mayor Pro Tem Rutledge stated that the Lake Palestine Resort was holding fishing tournaments that the EDC was sponsoring, and was supposed to be turning in information regarding who and where the money was spent, but he had not seen any paperwork yet. Mr. Beggerly said that only a few of the tournaments had qualified. He stated that only 3 of the tournaments thus far had

qualified, and that two that were supposed to qualify, had not and that the money for those tournaments was still being held for future qualifying tournaments.

## 14. Municipal Court Report

Judge Bivens stated that for the month of May there were 181 new cases filed, 36 cases were satisfied by drivers' safety, 20 cases were satisfied by deferral, 2 cases satisfied by proof of insurance, 4 cases satisfied by jail credit. There were no warrants issued due to the Governors mandate. There was \$27,730.00 collected, and of that GHS collected \$11,184.00. The in-house warrant officer collected on \$3,885.00. She went on to say that the warrant officer was supposed to be meeting with her at the end of June to discuss the processes and procedures going forward.
