Difference between this contract with Seven Points and the previous contract is that we won't have to supply the 3 boxes of paper to Seven Points. Seven Points will mail Coffee City paperwork to the City Hall; instead of the Police Dept. having to go to Seven Points to retrieve the paperwork. Council Member Joy Woods made the motion to accept this contract between Seven Points and Coffee City. Henry Thirkill 2nd the motion. Motion was carried.

Mayor Ruthie Seward presented to the City Council the Court's Monthly Report because Judge Tarrant was absent.

Next was the Police Department: Chief Strickland came forth with a complaint about the Mayor & Secretary docking his paycheck for an hour pays. After the council reviewed Chief Strickland complaint; Council Member Henry Thirkill made the motion to pay Mr. Strickland for his 1 hour work on the next pay period. Darlene Jordan 2nd the motion. Next was the Discussion about the Auditors from Gollob, Morgan, Peddy&Co. The Auditors were unavailable to attend this meeting. City Secretary will check on the reasoning why the auditors were unable to attend this meeting. Council Member Cindy Craig made the motion to table the auditors. Joy 2nd the motion. Motion was carried.
