

ORDINANCE NO. 2015-08-10

AN ORDINANCE OF THE CITY OF COFFEE CITY, TEXAS PROVIDING FOR THE DESIGNATION OF THE OFFICIAL NEWSPAPER BY THE CITY OF COFFEE CITY, HENDERSON COUNTY, TEXAS FOR THE PURPOSE OF PUBLISHING EACH ORDINANCE, NOTICE OR OTHER MATTER REQUIRED BY LAW OR ORDINANCE TO BE PUBLISHED; AND PROVIDING FOR REVOCATION OF THIS ORDINANCE; PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Coffee City is a duly incorporate Type B general law municipality engaged in the provision of city government and related services for the benefit of the citizens of the City of Coffee City;

WHEREAS, pursuant to 52.004 of the Texas Local Government Code (Exhibit "A"), the City Council must designate as official newspaper for publishing ordinances, Notices, or other matters required by law or ordinance to be published for the City of Coffee City Coffee City, Henderson County, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COFFEE CITY, HENDERSON COUNTY, TEXAS:

SECTION 1. DESIGNATION OF OFFICIAL NEWSPAPER.

The City of Coffee City hereby designates the Frankston Citizen as the official Newspaper of the City of Coffee City, Henderson County, Texas, pursuant to Section 52.004 of the Texas Local Government Code, for publishing each ordinance, notice, or other matter required by law or ordinance to be published.

SECTION 2. REVOCATION, This Ordinance shall remain in effect unless and until such time as the City Council of the City of Coffee City shall repeal the same by ordinance.

SECTION 3. CONFLICTS. All ordinances and provisions of the City of Coffee City, Texas, that are in conflict with this Ordinance shall be and the same are hereby repealed, and all ordinances and provision of ordinances of said City not so repealed are hereby retained in full force and effect.

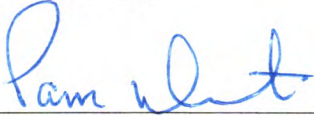
SECTION 4. SEVERABILITY, It is the intent of the City Council that each paragraph, sentence, subdivision, clause, phrase, or section of this Ordinance be deemed severable and, should any such paragraph, sentence, subdivision, clause, phrase, or section be declared invalid or unconstitutional for any reason, such declaration of invalidity or unconstitutionally shall not be construed to affect the validity of those provisions of this Ordinance left standing.

EXHIBIT "A"

§ 52.004. OFFICIAL NEWSPAPER.

- (a) As soon as practicable after the beginning of each municipal year, the governing body of the municipality shall contract, as determined by Ordinance or resolution, with a public newspaper of the municipality to be the municipality's official newspaper until another newspaper is selected.
- (b) The governing body shall publish in the municipality's official newspaper each ordinance, Notice, or other matter required by law or ordinance to be published.
